Why is Education Important?

Education equips individuals with the tools needed to be successful in life, both academically and non-academically.





Education and Crime

Poor education can lead to a steep increase in criminal behavior; receiving adequate education is a matter of public safety.





- A 10% increase in male graduation rate would reduce murder and assault arrest rates by 20%
- Increasing high-school completion rates by just 1% for all men would save the US up to \$1.4 billion per year in reduced costs from crime.
- State prison inmates without a diploma/GED are more likely to be repeat offenders than those with a diploma.



Education and the Economy


A good education produces national economic gains; conversely the effects of poor education drain the nation's economy.

- 60% of all new jobs in the 21st century will require skills that only 20% of the current workforce possess.
- By 2018, demand for students with an associate's degree or higher will exceed supply by 3 million workers.
- 22% of high school students do not graduate on time
- Nationally, 60% of 3-4 yr olds do not have math and literacy school-readiness skills

Where were we?

Increased education funding in recent years has led to increased student achievement.




- In 2010, CNBC ranked PA 4th in the nation in education in its Top States for Business.
- In 2003, 11 states beat Pennsylvania in 8th grade reading. In 2010, the state had the best scores in the nation.
- In 4th grade reading in 2003, 14 states were demonstrating better results than Pennsylvania's. Today we are in the top six.

History of Education Funding by the State

PA Ranks 4th in the Nation in our Dependence on Local Taxes



- For about 2 decades, state policymakers used political decisions to determine how much money a SD received
- Costing-out study determined : PA was under-funding K-12 education by more than \$4 billion
- In 2008, a funding formula based on need and disparities in wealth was adopted

National Averages are:
 • 48% from state funding
 • 44% from local districts

State Budget FY 2011-2012

- Biggest cut in state funding for basic education
- Cuts fall hardest on SDs w/ the greatest student poverty
- Budget will result to higher property taxes, elimination of proven practices and layoffs of teachers

- Budget continues to shift cost to local gov't & taxpayers
- Cements drastic budget cuts from last year.
- Money diverted to private schools is doubled

Recent Education Policy Issues

- Teacher Evaluations** – Sets a new system to evaluate teachers: 50% on a more-detailed version of the supervisor observation; 50% on a combination student improvement (graduation rates, PSSA, etc.) and elective data (student projects, district-designed measurements, etc.)
- Fiscally Distressed Schools**– creates an early warning system for school districts in financial distress and gives the state broad new powers to assign a recovery officer to districts and implement a financial recovery plan. Also created the Financial Recovery Transitional Loan fund.
- Special Education Funding**– SB 1115 would establish a funding formula hat would distribute funding for special education in an equitable manner based on the number of students with special education needs and the level of that need – future action expected in the fall of 2012

EITC 1.0 & 2.0 (Voucher lite)

- Education Investment Tax Credit (EITC) – increased by \$25 million
- Education Investment Scholarship Credit (EISC) – funded for \$50 million
- Re-direct dollars away from revenue collections, therefore reducing the amount of revenue the Commonwealth has to use for programs and services.
- Provides little accountability, law prevents the state from collecting more than minimum information on scholarships.



Charter Schools


- Charter schools are independent public schools that operate under a contract with the local school district..
- Recent legislation includes a statewide authorizer that would be able to bypass local input by school districts and taxpayers and allow charter schools to be created.
- Good Reform – should include fixes to the current funding structure, promote fairness, transparency and accountability.



What is Advocacy?





The process of informing decision makers and providing recommendations and promoting passage of a specific policy.




Why Do It?

Advocacy makes issues relevant to politicians and brings the issues back home to their district.

Types of Advocacy



- **Building a base** – organizing fellow constituents, educating them on the issues affecting public education and encouraging them to engage in the process.
- **Write letters** to the editor of your local newspapers and your local legislators on current education issues
- **Educating Legislators** on education issues voters are concerned about by providing them with relevant information on these issues
- **Legislative Visit** – meet with your local legislators to discuss educational issues you are concerned about and solutions you support
- **Voting** – encourage citizens to vote. We need legislators in Harrisburg that support public education.
